## **The Price of the Pint**

# Chapter 1: The Courtroom of the Covenant

## What is blood from a spiritual perspective

Blood is a spiritual portal; it is a means of transportation for demonic spirits to cross over from the spiritual realm into the natural. We see instances in the bible where blood is used as an atonement for sins under the old testament, as well as for occult practices in 1 Kings chapter 18 verse 28 with the false prophets of baal.

In the realms of witchcraft and darker spiritualities, blood serves as the ultimate currency for forging covenants with the demonic. Such rituals may promise a swift rise to power or prosperity, but these gains are always shadowed by an eventual, devastating cost. Much like a legal document, a blood covenant has a terminal clause. When the contract expires, the collection begins. The price of such a pact is often staggering—demanding the life of a loved one, a child, or ultimately, the soul itself. Like any high-stakes business arrangement, these covenants are bound by strict stipulations; if the practitioner fails to uphold their end, the spiritual protection is voided, often resulting in catastrophic retribution. This 'spiritual legality' is precisely why breaking free from witchcraft and black magic is so hard: it is not merely an influence to be shed, but a binding legal contract that must be formally annulled.

## The Judicial Reality of the Spirit

The spiritual realm functions as a high-stakes judicial system, governed by the immutable laws of the God of Israel. Central to this framework is the reality that God is a covenant-keeping God (Deuteronomy 7:9), upholding a divine jurisdiction under his sovereign authority as the ultimate judge (Psalm 7:11). Operating within this legal framework, the adversary—identified as the "accuser of the brethren" in Revelation 12:10—serves as a relentless prosecutor, seeking to secure convictions against the righteous by identifying points of spiritual and moral liability.

When an individual enters into a covenant with the kingdom of darkness, the adversary presents that contract as legal evidence before the throne of the God of Israel. He demands that the judge adhere to the standard of his own word according to Deuteronomy 7:9. Because the God of Israel is inherently faithful to his decrees and his word cannot return void (Isaiah 55:11), He is legally bound to honor the validity of a contract entered into by an agent of free will. To do otherwise would contradict his own nature and render his word unreliable—a spiritual impossibility.

These demonic contracts are rarely limited to the individual; they are structured with lineage-based liabilities that permits satan to operate within a family bloodline. As established in Deuteronomy 5:9 and Exodus 20:5, these spiritual agreements often carry stipulations that

remain legally enforceable for up to four generations. This creates a cycle of generational liability where the actions of a forefather can provide the legal grounds for the adversary to maintain a claim over a bloodline long after the original contract was signed.

## **Chapter 2: Identifying the Breach**

### **The Spiritual Reality of the Harvesting Station**

Through the lens of spiritual discernment, we must recognize that the plasma clinic is often a mirrored version of an altar. Under the law of the mimic, we understand that satan is not a creator, but a master of the counterfeit who simply mirrors the kingdom of heaven with his own kingdom of darkness. This spiritual symmetry is seen in every practice: where christians have altars, witches have altars; where christians pray and fast, witches pray and fast; and just as Jesus has disciples, satan has his own disciples as well. This mimicry extends even to the most powerful spiritual legalities. Holy Spirit-filled Christians "plead the blood of Jesus" to dismantle demonic forces, witches and satanic agents enter into blood covenants and perform blood sacrifices to lucifer to strengthen their demonic altars.

### **The Observation of the "Witch in the Clinic"**

When we look at the concentration of plasma centers, we aren't just looking at medical facilities; we are looking at spiritual harvesting stations. Just as the bible reminds us in Leviticus 17:11 that life is in the blood, the adversary knows that to control the blood is to control the portal.

Most people walk into a clinic seeing only a technician and the chance to make a few bucks, but spiritual discernment reveals that many of these environments are staffed by those who understand the occult value of what is being drawn. Just as a "Holy Spirit-filled Christian" uses the spiritual blood of Jesus for protection, these "satanic agents" use the physical extraction of body fluids to fuel their own dark, demonic altars. I again encourage you to read Leviticus 17:11, but this time in its entirety.

To the untrained eye, you may believe you are performing a good deed by saving lives; however, consider this: by donating blood, you are literally sacrificing your life. It gets even deeper when the phlebotomy technician performing your donation is a witch. When viewed through a spiritual lens, that donation is instantly transformed into a ritual.

In the regular christian church, we aren't taught to look at things like this because of two reasons: Spiritual ignorance and a lack of spiritual discernment. As a result of our spiritual ignorance, satan capitalizes by keeping people spiritually bound. We have to realize that satan

is a spiritual legalist. He knows the bible back and forth, and he will capitalize where we fall short. That's why Paul tells us in 2 Corinthians 2:11 that we are not to be ignorant of satan's devices.

## **Chapter 3: The Verdict of Spilt Blood**

Have you noticed that the majority of the people that donate plasma are either homeless, suffering from extreme financial crises, or uses the funds from their donation to support a drug or alcohol addiction? Now, I'm not saying everybody that donates are in these impoverished states, but most are, and I'm here to explain to you why. To give you the answer, we would have to go back to the beginning of this case study to chapter one and re-read about how blood is a form of a spiritual contract. When you do these things, the spiritual consequences are brutal.

Let's look at the cost of spilt blood in Genesis Chapter 4 when Cain killed his brother Abel and his blood was spilt. Let's get right to the conversation between the Lord and Cain after Cain slew his brother. In Genesis 4:9, the Lord asked Cain, "Where is your brother Abel?" Then Cain responds, "I don't know, am I my brother's keeper?" Then the Lord immediately says in the next verse, "What have you done? Listen! Your brother's blood cries out to me from the ground." Right here shows that blood is alive and is a living force with a voice in the spiritual realm.

Now here is the punishment. In Genesis 4:11, the Lord says to Cain, "Now you are under a curse." You see that? The result of spilling blood is a curse! So now is it made plain to you why the people that go to these labs and clinics are in the perpetual state that they are in? They are bound spiritually as a result of each donation. Now, the Lord can shine grace on the person that is in the bondage and deliver them from the curse of addiction and poverty, but it's going to take the person to first hit ultimate rock bottom and come to the realization that there is nothing that they can do without the blood of Jesus to help them overcome.

## **The Clarion Call: A Final Warning and Way Out**

We can no longer afford to walk through these clinics with our eyes closed. If this case study has shown us anything, it's that the "price of the pint" is far steeper than the few dollars in your pocket; it is a spiritual trade that gives the adversary a voice against your very life. But there is a way out. By recognizing these devices and repenting for the moments we acted in spiritual ignorance, we can finally silence the cry of the harvested blood. It is time to stop feeding the counterfeit altars and start standing on the finished work of the blood of Jesus—the only blood that speaks life where the enemy spoke a curse. Wake up, discern the atmosphere, and refuse to let your life-force be used as a ritual for the kingdom of darkness.
